

## Privacy Policy for Mobile App(s)

This privacy policy governs your use of the software application 'Younify' ("Application" - hereinafter referred as 'Younify' or 'App') for mobile devices that was created by Younify Pte Ltd. The Application is a way to connect venues with their guests, while offering them various features and functions.

We at Younify have committed ourselves to protecting your privacy. We use the information gathered to enable your account and to enhance your online experience. We endeavor to comply with laws of other countries but cannot and do not warrant that we do. We do everything we reasonably can to protect your rights of privacy on systems and the App controlled by us, but we are not liable for any unauthorised or unlawful disclosures of your personal and confidential information made by third parties who are not subject to our control, for example advertisers and websites/other sources that have links to our app. You should take note that the information and privacy practices of our business partners, advertisers, sponsors or other sites to which we provide hyperlinks, may be different from ours.

We respect the right of users to remain anonymous and will endeavour not to knowingly disclose user identities unless directed by a court of law. Our privacy policy is subject to change at any time without notice. To make sure you are aware of any changes, please review this policy periodically.

### **What information does Younify obtain and how is it used?**

#### **User Provided Information**

The App obtains the information you provide when you download and register the App. Registration with us is optional. However, please keep in mind that you may not be able to use some of the features offered by the App unless you register with us.

When you register with us and use the App, you generally provide (a) your name, email address, age, user name, password and other registration information; (b) transaction-related information, such as when you make purchases, respond to any offers, or download or use app from us; (c) information you provide us when you contact us for help; (d) credit card information for purchase and use of the App, and for placing any orders with third party restaurants and; (e) information you enter into our system when using the App, such as contact information and project management information.

We may also use the information you provided us to contact you from time to time to provide you with important information, required notices and marketing promotions.

### **Automatically Collected Information**

In addition, the App may collect certain information automatically, including, but not limited to, the type of mobile device you use, your mobile devices unique device ID, the IP address of your mobile device, your mobile operating system, the type of mobile Internet browsers you use, and information about the way you use the App.

### **Do third parties see and/or have access to information obtained by Younify App?**

Data may be periodically transmitted to venues, or other relevant third-parties as Younify may decide at the time, to help us improve the Application and our service. We will share your information with third parties only in the ways that are described in this privacy statement.

We may disclose User Provided and Automatically Collected Information:

- as required by law, such as to comply with a subpoena, or similar legal process;
- when we believe in good faith that disclosure is necessary to protect our rights, protect your safety or the safety of others, investigate fraud, or respond to a government request;
- with our trusted services providers, do not have an independent use of the information we disclose to them, and have agreed to adhere to the rules set forth in this privacy statement.
- if Younify Solutions Private Limited is involved in a merger, acquisition, or sale of all or a portion of its assets, you will be notified via email and/or a prominent notice on our Web site of any change in ownership or uses of this information, as well as any choices you may have regarding this information.

### **What are my opt-out rights?**

You can stop all collection of information by the App easily by uninstalling the App. You may use the standard uninstall processes as may be available as part of your mobile device or via the mobile application marketplace or network.

### **Data Retention Policy, Managing Your Information**

We will retain User Provided data for as long as you use the App and for a reasonable time thereafter. We will retain Automatically Collected information for up to 24 months and thereafter may store it in aggregate. If you'd like us to delete User Provided Data that you have provided via the App, please contact us at [support@younify.com](mailto:support@younify.com) and we will respond in a reasonable time. Please note that some or all of the User Provided Data may be required in order for the App to function properly

## **Children**

We do not use the App to knowingly solicit data from or market to children under the age of 15. We will delete such information from our files within a reasonable time.

## **Security**

We are concerned about safeguarding the confidentiality of your information. We provide physical, electronic, and procedural safeguards to protect information we process and maintain. For example, we limit access to this information to authorized employees and contractors who need to know that information in order to operate, develop or improve our Application. Please be aware that, although we endeavor provide reasonable security for information we process and maintain, no security system can prevent all potential security breaches.

## **Your Consent**

By using the Application, you are consenting to our processing of your information as set forth in this Privacy Policy now and as amended by us. "Processing," means using cookies on a computer/hand held device or using or touching information in any way, including, but not limited to, collecting, storing, deleting, using, combining and disclosing information, all of which activities will take place in India. If you reside outside India your information will be transferred, processed and stored there under Indian privacy standards. This Privacy Policy may be updated from time to time for any reason. We will notify you of any changes to our Privacy Policy by posting the new Privacy Policy here and informing you via email or text message. You are advised to consult this Privacy Policy regularly for any changes, as continued use is deemed approval of all changes.
